Module Aims

This module will introduce you to the role of the midwife and the provision of universal care to birthing people and their neonates. It will support progression towards achievement of the NMC standards of proficiency for midwives (2019) and preparation to practice safely and effectively at point of registration. You will also work towards completing the Directive 2005/36/EC requirements for practical and clinical training of midwives (NMC 2019).

Outline Syllabus

Universal care, Continuity of care, Relationship building, Infant feeding, Communication, Public health, Medicines administration, Record keeping.

Learning, Teaching and Assessment Strategy

During the first year you will participate in the provision of care for birthing people, their babies and their families. You will work closely with midwives and other health and social care practitioners, under direct supervision and direction, appropriate to your knowledge and skills. The expectations of professional behaviour and academic knowledge and skills are specific to your progression as a first-year student midwife and are documented in an electronic midwifery ongoing record of achievement (e-MORA). This module is delivered alongside the theory modules Beginning Midwifery Knowledge 1, 2 and 3 and Transition to Professional Self 1, which supports the appplication of theory to practice and opportunities to practice for practice.

Your progress will be assessed in a range of placements as part of a continuous assessment process and should not be viewed as separate elements but reflect the continuum of care provided in partnership with birthing people and their families. Practice Supervisors are required to regularly provide written feedback on your progress and confirm that you are meeting the required professional behaviour standards. This feedback will inform your ongoing development and the holistic assessment that your Practice Assessor will complete (learning outcomes (LOs) 1,2).

Two interim interviews will form the formative aspect of this assessment to judge how you are progressing throughout your practice and action plans will be written to help you attain your final goals (LOs1,2)..

To consolidate your learning, you will complete a written reflection on an aspect of your practice. Formative feedback on your draft work is available from your personal academic tutor (PAT) (LO 3).

You will pass the numeracy test at 80% (SafeMedicate)

Your progress will be reviewed by your Practice Assessor (PA) in clinical practice and your Academic Assessor (AA) twice formatively (end ofsemester1 and 2) and then summatively at the end of each year. The PA and AA will evaluate and recommend you for progression to the next stage of the programme as part of the summative holistic assessment at the end of semester 3 in line with SSSA standards (NMC 2018) and the programme standards. You must pass the summative holistic assessment to progress to year 2.

If you have the pre-requisite experience in clinical practice, youmayhave proficiencies delegated for year 2 signed off in year 1.

Should concern be raised about your ability to meet the required proficiencies in year 1, a tripartite meeting will be arranged with you, your Practice Assessor (PA) and your Academic Assessor (AA). Anappropriate action plan will be agreedwhich enables you to carry up to a maximum of 10% of the proficiencies from year 1 into the next part of the programme subject to satisfactory completion within a negotiated time frame.
