Module Aims
<p>The module aims to provide you with knowledge and understanding of the law governing immigration and asylum in the United Kingdom through examination of relevant legal concepts, principles and regulation. You will explore a variety of ideas and ideologies, theories and discourses to consider the legal doctrine governing immigration and asylum in the wider historical, political, sociological and economic context. You will consider the application of immigration and asylum law in practice.</p>

Outline Syllabus
<p>The origins and context of modern UK immigration, nationality and asylum law; the relationships between family and marriage and immigration control; family unity, reunification and European Union law; immigration for temporary purposes, including education, employment, business and visits; the law relating to asylum, refugees and exceptional leave to stay; the impact of UK, European and international human rights law; administration, tribunals and the courts; expulsion and remedies, including deportation, illegal entry and removal, detention and bail; appeals; Enforcement including detention, deportation, removal, the criminal justice system and Article 8; the 'Crime' of Seeking Asylum; exclusion and anti-terrorism; immigration ideologies and discourse; identity and assimilation.</p>

Learning, Teaching and Assessment Strategy
<p>This module considers immigration and asylum law in three distinct parts. Firstly, the relevant law will be placed in its wider multi-disciplinary context. This then leads you into exploring the substantive UK, EU, international legal doctrine, with a specific consideration of human rights which permeates teaching on this module. Lastly, the law thus studied is considered from a range of ideological and theoretical perspectives (LOs 1, 2, 4, 6). Learning is through the medium of lectures reinforced by staff-led tutorials.</p> <p>Teaching delivery on this module will be through lectures and tutorials. These will consider various theoretical questions, cases and case studies, upon which oral feedback will be given in class. Most of the time allocated to this module will take the form of directed study where you will be required to research primary sources, journal articles and other resources to explore the various concepts central to this module. You will also be required to present your findings and analysis in class (LOs 3,5). All teaching and learning is supported by information (including the module handbook) provided on Canvas, our virtual learning environment</p> <p>During the course of the module you will be required to complete formative assessment as part of your tutorial work, details about which shall be provided during the course of the module. One summative presentation will be set for completion during the module and you will complete a final piece of summative coursework at the end of the module. (All LOs).</p>
