#### Module Aims

The module will evaluate the extent to which current environmental law and policies provide suitable mechanisms for achieving sustainable human and environmental futures. The module covers a number of emerging subjects of environmental regulation such as the connection between climate policy and energy policy, specifically in relation to renewable sources of energy as well as unconventional and controversial sources of energy such as fracking.

## Outline Syllabus

The module covers the following issues:

- Introduction to modern environmental law and regulation, the role of international policies and treaties, and EU environmental law and policy.
- Drawing on a number of legal materials the module will explore the complex social, economic and political context in which environmental law exists.
- It will consider some current and emerging environmental issues of major international concern, e.g. nature protection, climate change and its interaction with energy policy, pollution control, and the relationship between international trade and the environment.

The teaching method promotes knowledge and understanding of environmental law and allows for the development of various skills, including analysis, synthesis, critical judgement, evaluation, and legal research skills (LO1 and LO2).

The module assignment tests the knowledge and understanding of environmental law trough demonstration of various skills, including analysis, synthesis, critical judgement, evaluation, and legal research skills (LO1 and LO4) as well as the ability to write appropriately using legal language and citing relevant legal authorities (LO2 and LO3).
