Module Aims
<p>On completing the module you will be able to diagnose where change is needed and select and apply a range of strategies and methods for managing change successfully; to select, analyse and apply a range of quality and service improvement tools, techniques and methods to improve quality and delivery of your service; and manage projects effectively. Also, to manage the more complex behavioural and organisational issues of change and lead individuals and teams to deliver change and improvement across diverse professional, functional and hierarchical boundaries.</p>

Health & Social Care Policy context in relation to quality and service improvement Measuring and managing quality - including setting & monitoring standards, performance indicators Quality & Service Improvement tools and techniques Change management theories and approaches Leading teams through change - managing resistance to change and conflict Managing systems and systems theory; working across organisational boundaries Change management frameworks, models and tools -planning, implementing & evaluating successful change Models and frameworks for managing projects.

Learning, Teaching and Assessment Strategy

LO 1,2 are developed & achieved through a series of research informed asynchronous online lectures that cover key topics.

The knowledge and theory introduced in these asynchronous lectures will be further explored in four synchronous workshop days delivered on campus or online (subject to circumstances), which will provide students with opportunity to discuss & analyse topics and to improve their understanding of the material covered in the module (LO 1-6). These workshop days are supported with synchronous online seminars and student-centred independent learning,

Extensive use is made of the Virtual Learning Environment & this medium is used to complement asynchronous online lectures and the synchronous online seminars, as well as to support students.

Time is allocated within the module for students to engage with interactive learning objects (including relevant websites, documents & a range of online resources such as video clips & blogs etc.) designed and packaged to support specific learning objectives (LO 1-6). This is underpinned by independent study time.

All LO are assessed via a written assignment of 4000 words. Students will be able to submit a 500 word draft essay plan prior to the final submission date & receive formative feedback.

Please note seminars will be either online or face to face. All students will have the four 1 hour seminar sessions. The delivery of the seminars is different for fulltime and part students.

1. Full time students seminars are ALL FACE TO FACE for 1 hour - see timetable for rooms
2. Part time students seminars are ALL ONLINE via a teams link for 1 hour.
