Learning, Teaching and Assessment Strategy

This module adopts a range of virtual learning and teaching activities to facilitate your learning. Research informed key lectures will introduce, discuss and apply topics and concepts; through seminars and an online resources.

The student will have the opportunity to explore and evaluate principles and techniques through the means of group learning, seminars.

Students will learn how to effectively present the arguments and proposals to in a business case scenario

The assessment strategy will focus on 2 areas: Preparing the nurse to transform nursing practice, and an advanced level of understanding of the context, management and leadership required to facilitate the transformation of health and social care service. It will comprise of 2 summative assessments.

The written component will assess your ability to generate a proposal for practice: a change or innovation, identify, appraise, and synthesise the material to support your case with valid and reliable evidence. You will also need to identify an evaluation strategy.

The module will also include an oral examination / Viva - presentation to Service users, academics and local health care providers focussed on the implementation of a service change or innovation.

The combination of written and oral examination/ viva methods will enable you to demonstrate your ability to progress and lead nursing practice; and to act as an agent of transformation.

Formative assessment opportunities will be available in preparation for both summative assessment tasks. You will have the opportunity to engage with your supervisor to discuss and receive feedback on your presentation topic through. You will be able to submit an extract (up to 10%) of your final piece of work, to receive feedback and direction.

The Nursing and Midwifery Council (NMC) require all learning outcomes to be passed, without compensation. To adhere to this requirement all components of assessment must be passed to achieve an overall module pass.
