Module Aims

The aim of this module is to facilitate your transition to registered nurse by enabling you to build on your knowledge and skills underpinning the delivery of integrated, safe and effective family centred care to children, young people and families.

You will explore through synthesis of critical reflection, the challenges of managing and leading high-quality evidence based practice within the context of contemporary children's health policy

Outline Syllabus

Using appropriate and evidence based assessment tools assisted by a digital platform assess, plan, manage, deliver and evaluate care to the child and family across all settings for the following: metabolic disorders, cystic fibrosis, cerebral palsy, epilepsy, end of life and palliative care; renal and complex neonatal conditions.

Understand the use of local, national policies and service developments in relation to care of children and young people; developments in service delivery, specialist areas of practice including organ donation, transition to primary care, ambulatory care, community and social care services; withdrawal of treatment and community care of children and young people.

Recognise the importance of communication; inter professional communication, de-escalation techniques and communicating with families under stress and service user involvement in care.

Recognise accountability in prescribing responsibilities and complex decision making, and management of digital technology.

Understand the role of the nurse as a leader and manager in care delivery, transition from student to registered children's nurse.

Delivery of nursing procedures: self-administration of medicines for children and families, and management of adverse drug reactions.

Learning, Teaching and Assessment Strategy

The summative assessment for the module is a single written Critical reflection and synthesis of the nurses role in managing the care of a child/young person with complex needs, with a maximum word limit of 3,000 words.

You will be supported to prepare for your summative assessment, you will have the opportunity to submit a detailed plan of your critical reflection which you will receive feedback on.
