## Module Aims

This module aims to provide you with the fundamental knowledge, skills, and attributes to allow you to begin to participate safely and effectively in health and care practice. Opportunities are provided within supervised practice settings to gain a practical understanding of the theory and skills developed in class. The module offers a bridge between education and the health and care workplace. On successful completion of the module you will be awarded with 'The Care Certificate'.

## **Outline Syllabus**

The syllabus is focused upon the fundamental, knowledge, skills, and attributes requisite of a novice clinician entering a care setting. Significant time will be dedicated to core practical skills such as effective and appropriate approaches to verbal and non-verbal communication and core care giving skills and the importance of reflective practice. You will learn to take into account factors such as age, capacity, learning and physical ability when interacting with service users. You will learn a range of movement and handling skills using a range techniques and equipment commonly deployed in ambulance and care settings. You will be taught the importance of establishing safe practice environments including infection prevention and control, dynamic risk assessment, and hazard perception/prevention/control, conflict resolution, and de-escalation techniques etc. You will also learn how to acquire routine baseline observations such as respiratory rates, manual blood pressures and ECGs.

## Learning, Teaching and Assessment Strategy

All learning, teaching and assessment on this module has been mapped against The 'Care Certificate' standards. Lectures will give you opportunities to cover underpinning theories. Workshops will give you opportunities to learn and practice skills including moving and handling, basic life support, fundamentals of care and patient assessment skills and basic airway management skills. You will be directed towards e-learning resources to prepare you for placement. Academic writing workshops will give you opportunity to receive support with assignment writing. Tutorials will be utilised to discuss your readiness for placement and progression on the course. Clinical Placements in a range of health and social care settings will give you the opportunity to practice your clinical and practical skills.

Your placements are designed to give you exposure to service users with some form of cognitive impairment. Prior to placement you will undertake contemporaneous assessments in basic ambulance and care skills. This will enable you to get the most from your placement as, throughout the module, you are required to produce a portfolio to evidence learning. This includes the completion of requisite practice placement hours and accomplishment of practice competencies. There are several placement competencies to achieve over the course of the year: these include skills in the three learning domains: psychomotor; moving and handling etc., affective; communication etc., cognitive; identifying vulnerable individuals. Additionally, you will be expected to complete action plans and SWAIN analysis (SWAIN stands for Strengths, Weaknesses, Aspirations and Interests) to display awareness of your own development needs. You will use a recognised model of reflection to produce a written assignment focused on a challenging episode of communication. This could, for example, relate to the care of a service user with dementia or learning disabilities. For many, this will be your first attempt at academic writing. We recognise this: class time will be utilised to help you to develop your academic writing and we will provide formative feedback to all of you before your final submission.

Formative assessment will occur throughout the module in skills workshops and practice placement areas, with opportunities to undertake mock assessment and receive feedback. Peer feedback wil be utilised to allow extensive formative feedback.

Learning outcomes 1-4 will be assessed by the written coursework. Learning outcome 5-6 will be assessed by the practical/laboratory exam. Learning outcome 7-9 will be assessed by Coursework/e-portfolio.
