Module Aims

This module aims to further develop and refine the skills and attitudes of professional conduct and to expand clinical competence in the care, monitoring, support and management of service users and their families during clinical practice. It will further develop critical thinking skills in order to analyse the evidence base informing clinical best practice. It will enable you to demonstrate professional attributes in the practical application of clinical skills under the supervision of a clinician, and to complete a portfolio of evidence which demonstrates ability to undertake a defined range of competences in clinical practice as an autonomous practitioner.

Outline Syllabus

The syllabus for this module includes exploration of the evidence base that informs the delivery of contemporary health and social care. The application of knowledge and clinical skills in the clinical learning environment will enable you to demonstrate the requisite patient assessment, management, clinical decision-making skills, resilience and professional attributes necessary for safe clinical practice. You will also begin to consider the impact of contextualised learning opportunities, educational theories / strategies, and the importance of supportive roles such as mentors, preceptors, and practice educators in bridging the theory practice gap.

You will be taught how to recognise a variety of conditions through history taking and physical assessment. You will learn how to manage these patients using the range of treatment modalities that are expected of the pre-hospital practitioner. Due to the undifferentiated nature of pre-hospital care you will learn to manage patients presenting with traumatic injuries, medical conditions, mental health conditions and cardiac arrests. You will also learn the principles of major incident management including how to report major incidents, how to triage patients and interprofessional working.

08	Discuss and assist in the administration of drugs under the direct supervision of a clinician with due regard to safety and legislation.			
09	Communicate professionally with service users, professional colleagues and others in a wide range of challenging situations; ensuring meaning is clear and unambiguous.			
10	Apply professional behaviours in the context of clinical practice and multidisciplinary team working with an emphasis on promoting health and well-being whilst promoting person-centred care.			
11	Curate a portfolio of evidence that shows the achievement of personal learning objectives.			

Learning, Teaching and Assessment Strategy

Lectures will inform and prepare you for learning in the clinical environment and enable you to maximise learning opportunities in different clinical settings.

Clinical Skills Practical Classes will deliver core content; practical sessions will be supported with live demonstrations and pre-recorded video materials, you will have hands on constructive practice time providing you with the opportunity to develop knowledge, skills, and conceptual understanding. Workshops will give you the opportunity to apply learning in simulated scenarios. During practical classes and workshops, you will be afforded immediate corrective and constructive feedback on their performance to help improve your clinical skills and knowledge.

You will be given guidance on completing a comprehensive electronic portfolio of achievements to evidence progress, professionalism, reflection, resilience and clinical competence. Clinical Placement will give you opportunities to apply their underpinning knowledge and skills to clinical practice and implement packages of care. Clinical practice-based learning will be supported by link lecturers and practice educators.

You will workwith a range of practice educators and should seek verbal and written feedback for reflection to take place. You are expected to show evidence of consistent progress during the module and including regular discussions with your practice educator to identify learning needs, proficiency, and confidence. Formative feedback will be given at the end of semester one by the academic team.

The module will also include a 2000-word essay critically analysing learning in practice. Seminars will give you opportunity to discuss your clinical placement, progress and application of underpinning knowledge and skills in practice

This is a practical module, much of the learning takes place in clinical placement and in the practical sessions when you will be preparing for placement and the practical assessments. Whilst on placement you must complete a portfolio of evidence demonstrating the competent assessment and management of a diverse range of patients in the pre-hospital setting by applying knowledge and clinical skills. To do so you are required to work alongside a practice educator for the required hours and evidence set competencies for a broad range of professional and clinical skills relevant to the role of a paramedic.

You must also evidence reflection on your own progress and learning needs throughout the module. You will be provided with placement opportunities in several clinical learning environments such as; emergency ambulances, operating theatres, maternity settings, mental health settings and emergency departments which are relevant to the skill set of a paramedic. These will enable you to produce a portfolio of evidence demonstrating the module learning outcomes. Formative feedback will be given on your portfolio at end of semester one to ensure that you are progressing well in this regard.

Often there can be a gap between what is taught in university and what you experience in practice. To help you to close this gap, you will also complete a written assignment which will evaluate the significance of the clinical learning environment. You will also reflect on the role that you and your practice educator can play in bridging this gap. It will help you to contextualise the three branches of evidence-based practice; clinical expertise, research and patient expectations. This assignment will be handed in earlier in the year and will help you gain the most from your clinical placements. You will be able to request formative feedback on this assignment no later than 7 days before deadline for submission.
