# Module Aims

This module is designed to provide an understanding of the nature and practice of foreign policy and diplomacy in contemporary international politics; and knowledge and expertise in professional skills and processes associated with international diplomacy and negotiation.

### **Outline Syllabus**

This module examines the nature, development, processes and practices of foreign policy, including: the dynamics and influences on the inter-governmental, bilateral, regional and international foreign policies of states; the development of diplomatic practice and the foreign policy of states in modern historical context; theories of foreign policy (e.g. rational actor, bureaucratic politics); the influence of domestic factors on foreign policy; contemporary practices of diplomacy and statecraft; international law and the role of international institutions (e.g. The United Nations, the European Union, the IMF and World Bank); and the relevance of norms, force and human rights in foreign policy. Case studies will be used to develop an understanding of how states make foreign policy as well as the domestic and external constraints faced by governments in achieving their foreign policy objectives. The module will further enable you to deepen your understanding of contemporary diplomacy and foreign policy dilemmas through experiential learning and through exercises and projects, including options to participate in the international 'Model United Nations' student exercise.

09	Apply and develop skills relating to the practice of international negotiations, crisis responses or problem solving relevant to employment in practitioner and policy communities in the area of diplomacy and foreign policies.
