Module Aims
<p>This module aims to apply and further develop knowledge and understanding from levels 4 and 5, through critical examination of the development, operation and effectiveness of international responses to complex crises, which typically involve policy and practitioner communities relevant to the BA programme International Relations, Politics and Security Studies. The module aims to develop your awareness, experience and skills through participation in crisis simulations and other games and exercises as well as through lectures, seminars and directed study.</p>

## Outline Syllabus

This module examines the issues, challenges and priorities involved in initiating, mobilising, designing, and implementing timely and appropriate international responses to complex emergencies or crises, drawing on and developing knowledge and understandings developed in levels 4 and 5. It examines international and regional crisis response mechanisms and practices in relation to disaster response, humanitarian aid and urgent poverty alleviation, complex political emergencies, gross abuses of human or minority rights, violent conflicts and civil wars, and inter-state security crises: and critically examines their operations through case studies.

The complex priorities, challenges and capacities required in each of these areas are explored, from the distinctive policy and practitioner perspectives associated with the BA Programme, but also in relation to overall design, co-ordination, civil-military relationships, and efforts to ensure conflict and gender sensitivity. Skills and understandings are further developed through individual and group exercises and projects, and also through a crisis game simulation exercise.

## Learning Outcomes

01	Develop and apply appropriate multi-disciplinary approaches to researching and analysing in detail: selected developments, trends, policy responses and practices relating to regional or international systems, institutions, norms and complex challenges or crises.
02	Analyse and critically evaluate contemporary debates relating to policy responses or practices on crises, including complex political, humanitarian, developmental, conflict or security crises.
03	Demonstrate initiative and independence in systematic academic inquiry, using relevant techniques and technologies to gather, evaluate and manage evidence, data and information from valid and appropriate sources.
04	Plan and execute a range of assignments, including essays, reports and reflective pieces, in which style, scope and depth are appropriate to task, purpose and audience.
05	Reflect critically on personal development as a scholar and policy analyst in the sectors of crisis response directly related to the BA IRPSS Programme of study, and also on the challenges of overall co-ordination, effectiveness and sustainability of international responses to crises: using evidence, feedback and insights from research and practice to make judgements about areas for personal development and progression.
06	Apply relevant theoretical frameworks and empirical evidence to a 'real-world' simulation exercise.

## Learning, Teaching and Assessment Strategy

Teaching and learning methods encompass lectures and seminars, workshops, group exercises including role-play and simulation exercises. It is expected that these will be all face-to-face unless public health or similar restrictions require online teaching.

Assessment covers all learning outcomes and the student contribution to all activities during the module, not only for the main crisis simulation game exercise.
