## Module Aims

This module focuses on countries which have experienced violent conflict. You will examine the complex factors and dynamics involved in understanding conflict risks and processes in conflict-affected areas, and approaches and methods for assessing peace-keeping and peace-building needs and development conflict-management and peace-building strategies.

You will examine and explore the changes that have taken place in peacekeeping and peace-building guidelines and missions in practice and analyse the different evaluations that have been made by academics, practitioners, campaigners and politicians. You will interrogate the concept of peacebuilding and analyse the ways in which its varying objectives have been addressed by different actors over time in different conflict-affected areas and regions across the world.

You will explore and deepen your understanding of these themes in the context of country case studies. You will undertake research, using both academic sources and accounts from international organisations, ranging from the United Nations to international Non-Governmental Organisations.

### Outline Syllabus

A typical year's syllabus covers the following areas. Not every topic will be covered in detail every year. Topical issues may be covered in more depth and others in outline only.

- > History and Practice of Peacekeeping and Peace-building.
- > The complex factors and dynamics of conflict, conflict-management and peace-building in fragile and conflict-affected countries and areas; and methods and approaches to analysing and assessing specific conflict and peace-building contexts.
- > Peacekeepers and UN Women Peace and Security agenda.
- > Integrated Missions and Peacebuilding.
- > Disarmament, Demobilisation & Reintegration (DDR).
- > Security Sector Reform (SSR).
- > 'Liberal Peace' debate.
- > Peacebuilding 'from below'.
- > Peacebuilding & Statebuilding.

02	Evaluate key theoretical debates in the field and apply key theoretical debates to the analysis of peace missions and other types of post-conflict intervention.			
03	Research and assess relevant documentation, and other information, from academic, official and advocating sources.			
04	Work independently to research an original written analysis of a peacebuilding or peacekeeping case.			
05	Work cooperatively in a group setting to produce a professional policy report.			

#### Learning, Teaching and Assessment Strategy

Teaching and learning will be through a blended learning strategy involving both on-line and face-to-face teaching. The teaching will be through a combination of interactive lectures, workshops and directed study to develop an understanding of key theories, concepts, policies and practices, and guides and illustrates application of these to analysis of cases and processes.

Summative assessment is achieved through a weighted combination of the groupwork project report and individual essay, which enables effective assessment of all learning outcomes. Preparation of a group project and research of an individual essay deepens and applies such understanding on selected topics, and develops both group and individual project/presentation skills (oral and written). Formative feedback on draft group projects and essays (up to 20% of the final submission) will be available. Supplementary assessment if required will be an individual contribution.
