#### Module Aims

To acquire knowledge in menopausal issues, gynaecological cancers, incontinence and prolapse enabling the student to develop skills to work confidently as a Practitioner with a Special Interest in Gynaecology.

#### Outline Syllabus

Menopause: premature menopause; diagnosis & management of the menopause; HRT - indications & contraindications, types, modes of administration, side effects, risks & benefits; alternative therapies; abnormal bleeding on HRT; when to refer for specialist advice; osteoporosis prevention, diagnosis & treatment; use of other treatments; SERMS, Bisphosphonates.Incontinence/Prolapse: history, examination & making a clinical diagnosis, treatment options in primary care - stress incontinnce, the overactive bladder; the role of appropriate physiotherapy, convervative management of prolapse including ring pessaries, what, who & when to refer, urodynamics, surgery for urodynamic stress incontinence & prolapse, secondary care management of the overactive bladder; the difficult bladder, e.g. voiding disorders, sensory bladder problems, pads/catheters.Gynaecological cancers; indications for fast track referral for suspected gynaecological malignancies; palliative care; overview of the management of gynaecological cancers; knowledge of further specialist investigations and/or when to refer appropriately.
